Welcome Message



It is indeed my pleasure to welcome you all to the 2023 Africa Arbitration Academy Flagship Training Programme. The Academy is an initiative of the foremost young arbitration practitioners' group in Africa – the Association of Young Arbitrators (AYA). The Academy was established due to the rising demand for improved expertise and training of arbitration practitioners in Africa and to expose young practitioners to the current trends and developments in international commercial and investment treaty arbitration. The inaugural Academy programme was held in London (June 2019) and was taught by international arbitration experts (academics and practitioners), heads of arbitral institutions, in-house counsel and judges. The overall objective of the Academy is to provide the much-needed specialized training to young arbitration practitioners from Africa and to equip them with the right set of skills to succeed within the international arbitration community.

The three-week advanced courses are offered in different formats including lectures, workshops and seminars. There are also mentoring sessions where renowned arbitration experts share career tips and life experiences with participants. Participants are involved in team building exercises, networking events in law firms, and mock arbitration hearings. Through the lectures, networking receptions, and workshops, participants expand their perspectives on international arbitration and are enriched with better professional skills and knowledge. The 2019 programme featured 25 participants from 13 countries. The 2021 programme features 30 participants from about 18 African countries and this year's programme in 2022 features 25 participants from 13 African countries.

Having successfully completed the three-week programme, participants move into the alumni of the Academy, and it is hoped that through the alumni, a new generation of arbitration practitioners with the requisite expertise to succeed in international arbitration, will emerge. The Academy continues to receive immense support from law firms such as Stephenson Harwood, Linklaters, Baker McKenzie, Clifford Chance, Herbert Smith Freehills, Freshfields Bruckhaus Deringer, White & Case, Hogan Lovells, WilmerHale, Pinsent Masons, Allen & Overy, Sidley Austin, Covington, Lalive, and Square Patton Boggs. It has also collaborated and received support from notable institutions including the International Centre for Settlement of Investment Disputes (ICSID), African Legal Support Facility (ALSF), International Chamber of Commerce (ICC), Cairo Centre for International Commercial Arbitration (CRCICA), Lagos Chamber of Commerce International Arbitration Centre (LACIAC), Mauritius International Arbitration Centre (MIAC), The Arbitration Foundation of Southern Africa (AFSA), Kigali International Arbitration Centre (KIAC), Nairobi Centre for International Arbitration (NCIA), Lagos Court of Arbitration (LCA), Asian International Arbitration Centre, Africa Arbitration, AfricArb, SOAS University of London and African Journal of International Arbitration (AJIA).

Since the inaugural programme in 2019, the Academy has been at the forefront of developments of interest to Africa and is always keen on leading the way to innovation and to developing the practice of international arbitration in the continent. In 2020, being concerned with the African dispute resolution landscape and consistent with its objective of being in the vanguard of policy reforms in Africa, the Academy realized that

it was timely to contribute to the advancement of arbitration on the continent given the COVID-19 pandemic. In April 2020, the Academy launched the Africa Arbitration Academy Protocol on Virtual Hearings in Africa. The launch of the Protocol was celebrated by the International Arbitration Community and in Africa as innovative, timely and important. Strikingly, arbitral institutions in Africa including in Lagos and Nairobi have adopted the Protocol for conducting their virtual hearings; and the Protocol featured significantly in the new Sierra Leone Arbitration Act 2022. The Protocol continues to draw commendations from stakeholders in the arbitration community for its innovations. It was voted “Innovation of the Year” at the Africa Arbitration Awards, held in Nairobi, Kenya in 2020 and at the 2020 AfAA Awards. The Protocol was also nominated for the GAR Pandemic Response Award in 2020 – recognizing innovative arbitration initiatives established to combat the effect of the pandemic.

The Academy is perceived as a game changer in the world of arbitration in Africa and is impacting the lives of practitioners in Africa. In 2021, the Academy published a Survey on Costs and Disputes Funding in Africa, with the generous support from the African Legal Support Facility (ALSF). This was the first Africa-wide survey to focus on costs of resolving disputes, the financing of claims, the impact of the COVID-19 pandemic on litigation and arbitration costs and measures to drive cost-efficiency in African disputes. The survey, indubitably, provides an empirical ballast and sheds light on how Survey on Costs and Disputes Funding in Africa businesses and stakeholders may approach costs of disputes in Africa – something which until now, was rarely explored.

In 2022, the Academy launched its Model Bilateral Investment Treaty for African States (AAA Model BIT). The AAA Model BIT sets out the investment policy framework for the promotion of foreign direct investments in Africa and provides a unique approach to balancing the relationship between investment promotion and sustainable development. The Model BIT has been designed as a comprehensive document comprised of uniform texts which African States may adopt as a basis for developing their specific model investment treaties, and also for non-African States when seeking to negotiate and conclude BITs with African States. Even if a State does not have a model investment treaty, this AAA Model BIT will be useful in considering how obligations are drafted. The preparation of the AAA Model BIT has been undertaken through an interactive and in-depth research process by a Drafting and Technical Review Committee consisting of seasoned arbitration and investment law experts drawn from different African States and the international arbitration and investment law community. It presents a modest contribution to the ISDS discourse and is an intellectual work product of the Africa Arbitration Academy. The AAA Model BIT won the "2023 GAR Award for Sustainable Behavior" at the Award Ceremony held during the Paris Arbitration Week in March 2023.
